3. HAZARDS IDENTIFICATION

Main hazards: Risk of serious damage to eyes. Harmful to aquatic organisms, may cause long-term adverse effects in the

4. FIRST AID MEASURES (SYMPTOMS)

Skin contact: There may be irritation and redness at the site of contact.

Eye contact: There may be pain and redness. The eyes may water profusely. There may be severe pain. The vision may

become blurred. May cause permanent damage.

Ingestion: There may be soreness and redness of the mouth and throat. Nausea and stomach pain may occur.

Eye contact: Bathe the eye with running water for 15 minutes. Transfer to hospital for specialist examination. **Ingestion:** Wash out mouth with water. Do not induce vomiting. If conscious, give half a litre of water to drink

immediately. Consult a doctor.

Inhalation: Remove casualty from exposure ensuring one's own safety whilst doing so.

5. FIRE-FIGHTING MEASURES

Extinguishing media: Suitable extinguishing media for the surrounding fire should be used. Use water spray to cool containers.

Exposure hazards: In combustion emits toxic fumes.

Protection of fire-fighters: Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes.

6. ACCIDENTAL RELEASE MEASURES

Personal precautions: Mark out the contaminated area with signs and prevent access to unauthorised personnel. Do not attempt to

prevent the escape of liquid.

Environmental precautions: Do not discharge into drains or rivers. Contain the spillage using bunding.

Clean-up procedures: Absorb into dry earth or sand. Transfer to a closable, labelled salvage container for disposal by an appropriate
