- 5. Neither the efficacy nor the phytotoxicity of the product for which this Extension of authorisation has been granted has been assessed and, as such, the user bears the risk in respect of failures concerning its efficacy and phytotoxicity.

ADVISORY INFORMATION

This Extension of Authorisation relates to the use of 'Hurricane SC' (M16027) for the control of Charlock, Common chickweed, Common field speedwell, Common poppy, Corn spurrey, Field mouse-ear, Field forget-me-not, Field pansy, Flixweed, Henbit dead-nettle, Ivy-leaved speedwell, Parsley piert, Red dead-nettle, Shepherd's purse, Treacle mustard, volunteer oilseed rape, Wild radish (Runch) on ornamental plant production (outdoor) and crops grown for game cover (outdoor). Application is to be made via conventional hydraulic or hand held sprayer in a minimum of 100 litres water per hectare. This notice sets out the full conditions of the agreed extrapolation.

IMPORTANT: When applying this product under the terms of this Extension of Use Notice, comply with any resistance guidance or restrictions stated on the product label.

Total reliance on one pesticide will hasten the development of resistance. Pesticides of different chemical types or alternative control measures should be included in the planned programme. Alternating with different modes of action is a recognized anti-resistance strategy

Strains of some annual grasses (e.g. black-grass, wild oats and Italian rye-grass) have developed resistance to herbicides why may lead to poor control. A strategy for managing and preventing such resistance should be developed. Guidelines have been produced by the Weed Resistance Action Group and copies are available from the HGCA, CPA, your distributor, crop advisor or product manufacturer

Environmental protection:

(1) Crops/situations with >5m buffer zone: Since there is a risk to aquatic life from use, direct spray from horizontal boom and hand held sprayers must not be allowed to fall within the distance specified for the crop of the top of the bank of any static or flowing waterbody or within 1m of the top of a ditch which is dry at the time of application.

Spray must be aimed away from water.

- (2) Buffer zones must be measured in accordance with the guidance set out in the HSE Chemicals Regulation Division's website and any amendments made to it.
- (3) The results of the LERAP must be recorded in written form and must be available for a period of three years for inspection to any person entitled to exercise enforcement powers under or in connection with the Plant Protection Products Regulations 2011 or the Plant Protection Products (Sustainable Use) Regulations 2012. (An electronic record will satisfy the requirement for a written record, providing it is similarly available for inspection and can be copied).
- (4) Where the buffer zone is greater than 5m then it must not be reduced under the LERAP scheme.

Other specific restrictions:

- (1) This product must only be applied in accordance with the terms of this extension of authorisation, the product label and/or leaflet and any additional guidance on extensions of authorisation.
- (2) For use on crops grown for game cover the seed or any part of treated plants must not be used for human or animal food or feed (except game birds).
- (3) For use on ornamental plant production the seed or any part of treated plants must not be used for human or animal food or feed.

APPENDIX 2: GENERAL CONDITIONS FOR AN EXTENSION OF AUTHORISATION

Failure to comply with the following conditions will result in the withdrawal or amendment of the Extension of authorisation under Regulation (EC) No 1107/2009 and may result in other enforcement action, including prosecution.

Adverse effects:

The authorisation holder must immediately notify the Secretary of State, the Scottish Ministers and the Department of Agriculture, Environment and Rural Affairs in Northern Ireland (care of the Health and Safety Executive), if they have any new information on the potentially adverse effects of the authorised product, or of residues of an active substance in that product when used in accordance with the conditions of this Extension of authorisation. For those products authorised under Regulation (EC) No 1107/2009 authorisation holders must also tell the other relevant competent authorities of the EC Member States (a list of which is available from the Health and Safety Executive) and the EC Commission. Failure to comply with this requirement is an offence.

Provision of information:

The authorisation holder must comply with all requests for information required by, or on behalf of, the Secretary of State, the Scottish Ministers or the Department of Agriculture, Environment and Rural Affairs in Northern Ireland in accordance with Regulation (EC) No 1107/2009.
