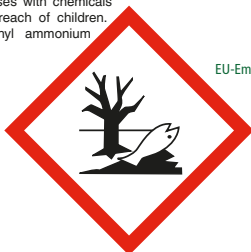
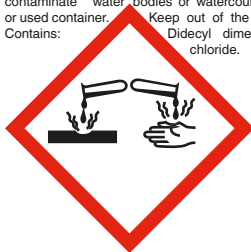

## DIRECTIONS FOR USE

**Ranger** is a professional biocide for use on external hard surfaces, including; roofs, driveways, pavements, concrete, around buildings and on artificial sports surfaces such as tennis courts to control moulds, fungi and algae.

**Ranger** is ideally applied as a spray. It can also be applied by brush or mop. It is essential that all areas to be cleaned are thoroughly wetted with the product. **Ranger** works on contact and continues to work for 5 to 7 days after application. In some instances a second treatment may be necessary. All surfaces may be used after the application has dried.

A new solution of Ranger should be made up daily.
