6. Accidental release measures

6.1 Personal precautions, protective equipment and emergency procedures

Personal precautions: Avoid inhalation of vapour, mist or spray and avoid contact with skin and eyes. Use suitable respiratory protection if ventilation is inadequate. Wear suitable protective equipment, including gloves, goggles/face shield, respirator, boots, clothing or apron, as appropriate.

6.2 Environmental precautions

Environmental precautions: Prevent large quantities of product from having contact with vegetation or waterways. Keep animals away from large spillages.

6.3 Methods and material for containment and cleaning up

Methods for cleaning up: Soak up product with absorbent material such as dry sand or earth and shovel absorbed substance into closing containers. Clean contaminated surfaces with an excess of water. Take care as floors and other surfaces may become slippery. Wash clothing and equipment after handling. Collect and dispose of spillage as indicated in Section 13.

7. Handling and storage

7.1 Precautions for safe handling

Protective measures: Use appropriate personal protective equipment. Do not ingest. Avoid contact with eyes, skin and clothing. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. Do not reuse container.

Measures to prevent fire: Keep away from open flames, hot surfaces and sources of ignition.
