<p>1. WILDLIFE</p> <p>Mammals and Birds</p>	<p>GRAZON is not classified '<i>Harmful to game, wild birds and animals</i>'.</p> <p>No risk management is necessary to protect wild mammals and birds. GRAZON and its active substances are of low toxicity to mammalian and bird species. The risk to wild mammals and birds feeding on treated areas is low.</p> <p><i>"KEEP LIVESTOCK OUT of treated areas for at least 7 days and until foliage of any poisonous weeds such as ragwort has died and become unpalatable"</i></p>
<p>2. BEES</p>	<p>No risk management necessary, and there is no requirement to avoid application of the product when bees may be foraging on flowering weeds.</p>
<p>3. NON TARGET INSECTS AND OTHER ARTHROPODS</p>	<p>No risk management is necessary.</p> <p>GRAZON poses a low risk to a range of arthropod species, such as beetles and spiders, commonly found in and around treated fields.</p>
<p>4. AQUATIC LIFE</p>	<p>GRAZON is classified as '<i>Toxic to aquatic organisms, may cause long-term adverse effects in the aquatic environment</i>'.</p> <p>GRAZON has a high toxicity to fish and algae and moderate toxicity to <i>Daphnia</i> (water fleas) and aquatic plants. Care must be taken to ensure that surface waters or ditches are not contaminated with the product or the used container.</p> <p>Risk management is essential. GRAZON can be used safely providing care is taken to prevent spray drift reaching surface waters. 4. AQUATIC LIFE (continued)	<p><i>“DO NOT ALLOW DIRECT SPRAY from horizontal boom sprayers to fall within 5 m of the top of the bank of a static or flowing water body, unless a Local Environment Risk Assessment for Pesticides (LERAP) permits a narrower buffer zone, or within 1 m of the top of a ditch which is dry at the time of application. DO NOT ALLOW DIRECT SPRAY from hand-held sprayers to fall within 1 m of the top of the bank of a static or flowing water body. Aim spray away from water.”</i></p> <p>LERAP Category B Buffer zones may be reduced (see LERAP Guidelines)</p>
5. SOIL and GROUNDWATER	<p>The active substances are impersistent or of moderate persistence, breakdown products are of moderate persistence, and all are moderately to highly mobile. However, when GRAZON is used as recommended there is a low risk of groundwater contamination.</p>
Earthworms	<p>GRAZON is of moderate toxicity to earthworms. However when used as recommended the risk to earthworms is low and no risk management is necessary.</p>
Soil Micro-organisms	<p>GRAZON is of low risk to soil micro-organisms. No risk management necessary in order to prevent risks to the processes of soil respiration and nitrogen turnover.</p>
6. NON-TARGET PLANTS	<p>GRAZON is a broad-spectrum herbicide, therefore care should be taken to minimise drift onto hedgerows, conservation headlands etc. in order to prevent damage to plants in adjacent areas.</p> <p><i>“Extreme care must be taken to avoid spray drift onto non-crop plants outside of the target area”</i></p>
